



SUBSCRIPTION AGREEMENT Terms and Conditions

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS OF USE BEFORE SUBSCRIBING TO OR USING THE “GAMACADEMY” WEB SITE (“Site”). This Site is owned and operated by Financial Services Education Network, LLC (“FSEdNet”) and contains material which is derived in whole or in part from material supplied by GAMA, FSEdNet, its affiliates and other sources (“Material”). The Material on this Site is the property of FSEdNet and by accessing or using this Site or other Materials, you agree to these terms of use, conditions, and applicable laws (“Terms and Conditions”). Use of the Material for any other reason not in accordance with these Terms and Conditions is strictly prohibited.

Use of Site. Personal and Non-Commercial Use Limitation.

Unless otherwise specified, the use of this Site and the Materials contained therein are exclusive for your personal use and may not be shared with anyone else. Use of the Site and the Materials by all other person are strictly prohibited. You may not use the Site, the Material or any other content contained therein for any purpose that is unlawful or prohibited by these Terms and Conditions, to solicit the performance of any illegal activity or other activity which infringes the rights of FSEdNet or others. All of this training material, as well as the FSEdNet and GAMA International (“GAMA”) content is password protected, for the exclusive use of only a single approved user. Each license is for an individual user, and their user IDs and passwords are not allowed to be shared. An individual user is not a firm, bank, or any other type of business, but solely one person. Abuse of this is grounds for termination of a user, it is agreed that GAMA will help us control this issue.

You may not modify, copy, reproduce, republish, upload, post, transmit or distribute in any way any Material from this Site including but not limited to code, software, and metadata. All rights, title and interest (including all copyrights and other intellectual property rights) in the Material on this Site (in both print and machine-readable forms) belongs exclusively to FSEdNet and its affiliates. By using this Site and the Materials you do not acquire any proprietary interest in any of the Material or copies thereof but merely a license to use such Material for your personal use.

Passwords and Security.

Portions of the Site are available on a paid subscription (“Subscription”) basis only. Authorized persons accessing the Site pursuant to a Subscription will be assigned a personal password to the Subscription-only areas of the Site. You are solely responsible for managing your password and for keeping your password confidential. You are also solely responsible for restricting access to any computer you use to access your Subscription account. Access to Subscription only areas of the Site is restricted solely to the purchaser of the Subscription as disclosed to FSEdNet upon purchase of your subscription. You agree that you are responsible for all activities that occur on your account or through use of your password by yourself or by other persons. Except for any personally identifiable information we may collect from you under the guidelines previously established in our Privacy Policy, any material, information, or other communication you transmit, upload or post to this Site will be considered non-confidential and non-proprietary and FSEdNet will have no obligations with respect to such communications. FSEdNet and its

designees will be free to copy, disclose, distribute, incorporate and otherwise use such communications and all data, images, sounds, text, and other things embodied therein for any and all commercial or noncommercial purposes.

Subscription Terms.

Access to the GAMAcademy is granted to those active members of GAMA International. GAMA has negotiated a discounted subscription rate, and in order to maintain this discounted rate, an active membership in GAMA must be maintained. If you end your membership with GAMA, then the full current non-discounted rates will automatically be charged starting on your next payment due date.

You may pay for a Subscription on a monthly basis payable monthly via a credit card authorization or on an annual discounted basis, again payable via a credit card. Subscription payments paid on a monthly basis must be received by FSEdNet on the first day of each month following the month the Subscription was purchased. The monthly subscription can be cancelled at any time after 90 days. The Annual is for 365 days, and if either is terminated early, there is no refund. Failure to do so will constitute a breach of these Terms and Conditions and may result in immediate termination of your Subscription. Your fully-paid Subscription will continue until FSEdNet receives written notification of termination from you as described herein, with a 30-notice. Further, there is a one-time payment only option, for access to a specific course offered on the site for a 30-day viewing period by you exclusively. All of the Terms and Conditions contained herein are applicable to these one-time payment subscriptions as well. You authorize FSEdNet to charge the credit/debit card account designated during the registration process for the current fees and expenses for each Subscription term according to the subscription plan chosen by you. You are responsible for any charges associated with connecting to the GAMAcademy Site. You shall provide FSEdNet with accurate, complete and updated information as to your name, e-mail address and all credit card information, including credit card number, expiration date, security code, name on the card and the billing address at time of registration and if any of this information changes, you will notify FSEdNet prior to next the billing date. Failure to do so shall constitute a breach of these Terms and Conditions.

Failure to accurately disclose the number of individuals accessing the Site under a Subscription plan at the time such plan was entered into shall constitute a breach of these Terms and Conditions.

Person(s) with access to the Site, the Materials or any content contained therein, pursuant to the terms of a individual or group Subscription, are hereby subject to the Terms and Conditions of this Agreement as if said person had purchased a Subscription individually and had been subject to these Terms and Conditions as a result thereby.

FSEdNet shall have the right at any time to impose, change or modify its fees and billing methods, or other terms and conditions applicable to your use of the Subscription or to impose new terms and conditions. Such changes, modifications, additions or deletions shall be effective immediately upon notice thereof, which may be given by any means including, but not limited to, posting on the Site a revised version of the Terms and Conditions or notification by electronic or conventional mail. Any use of the Subscription by you after such notice shall conclusively be deemed as acceptance by you of such changes, modifications, additions or deletions. You agree to review the Terms and Conditions periodically to be aware of such revisions. You may also be subject to additional terms and conditions imposed by third party content providers in connection with third party content, software, or services.

Either you or FSEdNet may terminate your Subscription at any time after the completion of either the 90-day or the 365-day subscription requirement pending upon which Subscription choice you made. Your

only right with respect to any dissatisfaction with (i) these Terms and Conditions, or policy or practice of FSEdNet in operating the Site and/or the forum areas, (ii) content available through the Subscription or change therein, or (iii) amount or type of fees or billing methods, or change therein, is to terminate your Subscription with FSEdNet by sending notice via certified mail to FSEdNet at 5551 N. University Drive, Suite 204, Coral Springs, FL 33067 or by e-mail to Support@FSEdNet.com. Notice of termination will be effective upon receipt by FSEdNet. Without limiting the foregoing, FSEdNet shall have the right to immediately terminate the Subscription with respect to any user which FSEdNet, in its sole discretion, considers to be unacceptable, or in the event of any breach by you. In the event your account is terminated or cancelled, no refund of any fees, including monthly or yearly membership fees, will be granted. Fees paid for any subscription are paid in advance and are not refundable in whole or in part.

Shipping and Return Policy.

GAMAcademy is solely delivered via our online platform. However, in the event that FSEdNet does ship material to you, then the following is agreed upon. All of your deliveries of printed Materials from FSEdNet will be shipped using USPS, UPS or a common carrier. Upon receipt of your merchandise, it is your responsibility to ensure quick resolution of any problems that occur during the shipping, including, but not limited to, the following actions: (1) check cartons for signs of damage, shortage on carton count or abuse, (2) if damages or shortages are discovered, you must make a notation on the bill of lading that describes the damage or shortage in detail, (3) you should open the cartons immediately and verify the contents, and (4) you may refuse any shipment that shows signs of damage or shortage at the time of delivery. Failure to follow any of these guidelines may restrict your ability to return the merchandise for replacement or refund as well as restricting your ability to claim any damage against FSEdNet. You may return all or part of any unused purchase within 14 days from the date of your invoice for a refund on the merchandise, provided the item(s) is in its original carton and is not a special ordered product. You are responsible for the returned shipping costs. There will be no refund for items returned after 30 days.

Monitoring.

FSEdNet shall have the right, but not the obligation, to monitor the content of the forum areas to determine compliance with this Agreement and any other operating rules that may be established by FSEdNet from time to time. FSEdNet shall have the right in its sole discretion to edit, refuse to post or remove any material submitted to or posted on the forum areas. Without limiting the foregoing, FSEdNet shall have the right, but not the obligation, to remove any Material that FSEdNet, in its sole discretion, finds to be in violation of the provisions hereof, otherwise objectionable or stale. Notwithstanding this right of FSEdNet, users shall remain solely responsible for the content of their messages. You hereby acknowledge and agree that neither FSEdNet nor any of its affiliates shall assume or have any liability for any action or inaction by FSEdNet with respect to any conduct within the forum areas or any communication or posting on the forum areas.

No Warranty.

Indemnification.

Applicable Laws.

Your use of this Site shall be governed in all respects by the laws of the state of Florida, without regard to choice of law provisions. You agree that jurisdiction over and venue in any legal proceeding directly or indirectly arising out of or relating to this Site shall be in the state or federal courts located in Broward County, Florida. Any cause of action or claim you may have with respect to the Site must be commenced within one (1) year after the claim or cause of action arises. FSEdNet may assign its rights and duties under this Agreement to any party at any time without notice to you. FSEdNet makes no representation that the content in the Site is appropriate or available for use in other locations, and access to them from territories where their content is illegal and prohibited. Those who choose to access this Site from locations outside Florida do so on their own initiative and are responsible for compliance with applicable local laws.

Miscellaneous.

These Terms and Conditions may be changed from time to time by FSEdNet. Charges and payment terms may be changed from time to time by FSEdNet upon notice. All other provisions may be changed by FSEdNet from time to time upon notice. Continued use of the Site following any change constitutes acceptance of the change. FSEdNet may terminate the Subscription for access to the Site.

The effective date of termination shall be seven (30) days after the receipt of an appropriate notice of termination, unless a later date is specified in the notice. FSEdNet may suspend or discontinue providing the Site and Material contained therein to you without notice and pursue any other remedy legally available to it if you fail to comply with any obligations herein.

Except as otherwise provided herein, all notices and other communications hereunder shall be in writing and notices shall be deemed to have been properly given on the date deposited in the U.S. mails, if mailed, on the date first made available, or on the date received, if delivered in another manner.

The failure of FSEdNet or any of its affiliates or licensors to enforce any provision hereof shall not constitute or be constituted as a waiver of such provision or of the right to enforce it at a later time.

The subscribing organization or individual may not assign its rights or delegate its duties under the Subscription to access the Site or the Materials without the prior written consent of FSEdNet.
